Finds of the Month Competition

Some Notes on the Finds of the Month Competition

After going over the Finds of the Month entries in August it became clear we need a review of criteria for each category.

3 Dig & Find Coinshooters & Historic Club

First, single versus group. Single means one individual item or something found as a unit. For example, a necklace with a pendant attached is a single item. A necklace found next to a pendant are two separate items. Only one could be placed in the single category. Don't put more than one entry in a subcategory, you're just splitting the votes you can receive.

Jewelry means items of personal adornment, such as rings, earrings, necklaces, etc., plus watches, medallions, and crucifixes and other religious articles.

Coins include coins, tokens and medallions.

Artifacts must be old, at the very least before 1950. Toy cars are not artifacts unless they are clearly from the 1930s or before. Cell phones, sunglasses, e-cigarettes, lead sinkers, zippers, etc. should be displayed as Miscellaneous. If you can't tell how old the find is, put it in Miscellaneous NOT Artifact. Artifacts can include nonmetallic items found while detecting such as antique marbles and bottles.

Miscellaneous is for everything that doesn't fall into the previous four categories. Miscellaneous can also include nonmetallic items.

Anything going into the first four categories must have been found since the last meeting we had a Finds of the Month competition. An exception is made for items that were found but not available due to laws until after the regular period, which basically means things found in the UK hat have been held under the Antiquities laws and are later released for export.

Display is for items found outside the "monthly" time period as well as anything historical or

interesting (Please make it interesting). Display items do not have to be metal detecting related.

When entering an item, please take a number slip, WRITE YOUR NAME ON IT, and leave it in the container provided on the finds table near to the pencils. Use that number for all your entries that month.

A final note on the Second Chance Drawing. If you enter items in the Finds of the Month, you will get one ticket for the Second Chance Drawing for each major category, except Display, in which you have a find. Enter in Coin, single and you will get one ticket. Enter in Coin, single and Coin, group and you will get one ticket (not two).

The maximum number of tickets you can receive each month is four.

Enter in Display single, group or both, you will get no tickets. That is because the purpose of the drawing is to encourage people to enter things they found metal detecting even if they don't think they will win a prize. We want to see what you're finding. So bring those finds in becasue the Second Chance Drawing Prize is always worth about \$5.

Those who agree with us may not be right, but we admire their astuteness.
